## Civil Engineer -

- Chief handed the trustees a packet pertaining to the Denny Road property
  - o Packet includes the new outline and phases
  - o Civil engineer RFP that Cordogan and Clark put out
  - o Updated master plan
- Removed front parking lot from phase 1 to phase 2
- Extra items removed include the flagpole, sign, gutter and curb removal
- New budget, including \$718,000 for training cans, comes to 2.7m, budgeted 1.7m
- This will bridge 2 budget years
- Received 4 different proposals
  - o Recommends Bono Engineering they have worked with them in the past
  - o Boundary and plat survey have this with JLH removed this from the proposal
  - o Bono engineering will work on zoning and pretest for septic, and get ready for bid
- Would like to have the trustees approve the hire of Bono Engineering
- Trustee Cicero stated he would like to keep an eye on the money being spent

Motioned by Fagel Seconded by Lamela to Accept the Proposal from Bono Engineering not to exceed \$40,000, pending attorney review of contract.
